THE COLUMBARIUM

INTRODUCTION

The Dean, Wardens and Vestry of Christ Church Cathedral have constructed a Columbarium on the grounds of the Cathedral so that parishioners and their families may plan for the interment of their ashes within the precincts of the Cathedral.

The Columbarium is located in the Sixth Street patio (the Bishop's Garden) next to Stuart Hall. It consists of 272 niches for the interment of ashes. Two interments are possible for each niche. Sales and interments are limited to Cathedral parishioners and their families. Active or retired clergy canonically resident in the Diocese of Louisiana may also purchase niches for themselves and their spouses.

The price of a niche is \$2,500.00. It should be noted that charges for the bronze faceplate bearing the names and dates of persons interred is an extra charge, and for a second interment in the same niche a new faceplate must be ordered.

RULES AND REGULATIONS OF CHRIST CHURCH CATHEDRAL COLUMBARIUM

- 1. THE CATHEDRAL shall at all times have full control of the Columbarium. Such control shall be exercised through the Dean and confirmed by the Vestry.
- 2. THE COLUMBARIUM: The Columbarium shall consist of 272 burial niches for the interment of the ashes of cremated bodies. Each niche shall be sold with a blank cast-bronze faceplate of uniform size. At the time of purchase the niche owner may order a cast-bronze faceplate stating only the family name(s) of the person(s) to be interred. At the time of each interment a new cast-bronze faceplate may be ordered stating only the name(s) of the deceased, date(s) of birth and date(s) of death.

Nothing except the faceplates with names and dates as described above may be affixed to the Columbarium units or to the walls around them. Nothing shall be placed on the floor under or around the Columbarium units without approval of the Dean. No more than the ashes of two (2) persons may be interred in any niche. All containers for ashes must conform to a size that will fit into the opening of the niche which is $8\frac{1}{2}$ " × $8\frac{1}{2}$ ". The interior size of each niche is 12" × 12" × 12".

3. ELIGIBILITY: The following restriction are subject to the discretion of the Dean. Sale of the niches is limited to parishioners of the Cathedral. Interment is limited to:

a.) Cathedral parishioners

b.) Spouses and immediate family of Cathedral parishioners.

c.) Former Cathedral parishioners and their immediate families.

- d.) Active or retired clergy canonically resident in the Diocese of Louisiana, and their spouses.
- 4. PRICE: The price of the exclusive rights to a niche shall be \$2,500.00 due at the time of selection. This payment is non-refundable unless a waiver is obtained from the Dean. The right to select an individual niche shall be given to purchasers in the order in which payments are received. There will be no assessments or charges after the purchase price has been paid, regardless of a later increase in purchase price. The cast-bronze faceplates, described above, are not included in the purchase price and the faceplates must be ordered from the manufacturer.
- 5. EXCLUSIVE RIGHT: The exclusive right to use a reserved niche shall not be sold or otherwise transferred without written permission from the Dean, and any such sale or transfer shall be limited as is stated in Rule 2 above. The right may be surrendered to the Cathedral. The Dean, at his discretion, may waive the non-refundability rule with respect to all or part of the purchase price.
- 6. CHANGE OF ADDRESS: Should any purchaser fail to inform the Parish Administrator in writing of a change of address and should the Parish be unable to locate the purchaser through reasonable diligence, after a 3-months search, the Parish reserves the right to cancel the right of the purchaser to use the niche.
- 7. COMMITTAL SERVICE: No cremated remains may be interred in a Columbarium niche without an appropriate burial service approved by the Dean.
- 8. REMOVAL: No interred remains may be removed from the Columbarium without an appropriate court order.
- 9. GENERAL: The above policies and regulations, with the exception of the provisions stated in Paragraph 3, Sentence 3, may be altered, amended or replaced at any time by action of the Vestry.
- 10. LOUISIANA LAW: The Columbarium is maintained in accordance with Louisiana law related to cemeteries. Nothing herein, or which may be established in the future, shall derogate, or vary, from Louisiana law.
